

**METES & BOUNDS** 294.99 ACRES G. WAGGONER SURVEY, ABSTRACT NUMBER 871, & S. BOSTICK SURVEY, ABSTRACT NUMBER 43,

WISE COUNTY, TEXAS

FIELD NOTES to all that certain lot, tract or parcel of land situated in G. WAGGONER SURVEY, ABSTRACT NUMBER 43, Wise County, Texas, and being the remainder of a called 140 acre tract of land described as "First Tract" and the remainder of a called 80 acre tract of land described as "Second Tract" and being all of a called 60 acre tract of land described as "Fourth Tract" in the deed to Wendell Elliot recorded in Volume 106, Page 521, Deed Records, Wise County, Texas the subject tract being more particularly described as follows:

BEGINNING at a cross tie wood fence corner post found in the Northeast line of said G. WAGGONER SURVEY, ABSTRACT NUMBER 871, and the Southwest line of said "Fourth Tract" for an interior ell corner of the herein described tract of land, same being the East corner of a called 150.75 acre tract of land described in the deed to Ronnie M. Woods and wife, Verona Woods recorded in Instrument Number 355060, Official Public Records, Wise County, Texas;

THENCE North 45 Degrees 18 Minutes 20 Seconds West with the Southwest line of said "Fourth Tract" and the Northeast line of said "Fourth Tract" and the South corner of said "First Tract" and continuing on said course along or near a fence most of the way a distance of 2,712.96 feet to an X-Cut set in a concrete bridge in the Southeast line of a called 108.78 acre tract of land described in Instrument Number 201502870, Official Public Records, Wise County, Texas said bridge being in an asphalt road under apparent public use known as Parker Dairy Road for corner;
