**THENCE** along the line common to this 19.629 acres and said Rawe 101.396 acres, North 59 degrees 59 minutes 51 seconds East (called North 59 degrees 00 minutes 09 seconds East), a distance of 902.46 feet (called 903.22 feet) to a 1/2-inch iron rod found for the North corner of this 19.629 acres, same being the northwest corner of the Jerome Gary Kiolbassa, et ux, 3.018 acres (Volume 5295, Page 1214);

**THENCE** along the line common to this 19.629 acres and said Kiolbassa 3.018 acres, South 30 degrees 20 minutes 35 seconds East (called South 30 degrees 37 minutes 06 seconds East), a distance of 948.72 feet (called 946.39 feet) to a 1/2-inch iron rod found (monument of record dignity) for the East corner of this 19.629 acres, same being the South corner of the Wendy W. Huston 2.009 acres (Volume 18014, Page 2486) and on the northwest line of the Michael A. Hunter 9.536 acres (Volume 11929, Page 1002);

**THENCE** along the line common to this 19.629 acres and said Hunter 9.536 acres, South 59 degrees 44 minutes 30 seconds East (called South 59 degrees 04 minutes 06 seconds West), a distance of 903.48 feet (called 903.22 feet) to a 1/2-inch iron rod found for the South corner of this 19.629 acres, same being the West corner of said Hunter 9.536 acres and on the northeast line of the aforesaid Bauer 14.309 acres;

**THENCE** along the line common to this 19.629 acres and said Bauer 14.309 acres, North 30 degrees 16 minutes 53 seconds West (called North 30 degrees 37 minutes 02 seconds West), a distance of 945.14 feet (called 945.34 feet) to the **POINT OF BEGINNING**, and containing 19.629 acres of land, more or less.
