Williamson in Volume 3810, Page 194, said Official Public Records;

THENCE North 87 deg. 59 min. 14 sec. West, with the North line of both said Carettini 62.62 ac. and said Williamson 2.00 ac., with a South line of said Anderson & Stowers 53 ac., a distance of 621.05 ft. to a 10 inch wood post at a fence corner, at the Northwest corner of both said Carettini 62.62 ac. and said Williamson 2.00 ac., at an Ell corner of both said Anderson & Stowers 53 ac. and the herein described tract;

THENCE South 03 deg. 01 min. 35 sec.
