

BEGINNING at a ½" rebar set for the Southeast corner of this tract being in the East line of the 30.00 acre parent tract conveyed to The Veterans' Land Board of the State of Texas being the Northeast corner of that 15.00 acre tract conveyed to Manuel Soriano by Warranty Deed recorded in Vol. 3574, Page 631 O.P.R. and bears N 00 deg. 59 min. 04 sec. E 755.16 ft. from a 5/8" rebar found for the Southeast corner of same and being in the West line of that 9.983 acre Tract 3 conveyed to Tracy Sullivan by Warranty Deed recorded in Vol. 7422, Page 535 O.P.R.;

THENCE N 89 deg. 56 min. 59 sec. W 865.19 ft. with a barb wire fence to a ½" rebar found for the Southwest corner of this tract being in the East occupational R.O.W. line of County Road 3168 being the Northwest corner of that 1.00 conveyed to James D. Cummings by Warranty Deed recorded by Clerk's Instrument No. 20150100003809 O.P.R.;

THENCE N 00 deg. 59 min. 07 sec. E 753.87 ft. along said East R.O.W. line to a ½" rebar found for the Northwest corner of this tract being in the roadbed of County Road 3118 and bears N 21 deg. 19 min. 28 sec. W 25.92 ft. from a x-tie fence corner post;

THENCE S 89 deg. 57 min. 31 sec. E 865.19 ft. with said roadbed to a ½" rebar set in same for the Northeast corner of this tract and being the Northwest corner of said 9.983 acre tract;

THENCE S 00 deg. 59 min. 07 sec. W 754.00 ft. along the West line of said 9.983 acre tract being the East line of this tract and partially with a barb wire fence to the point of beginning, containing 14.974 acres of land as surveyed by George Taylor, R.P.L.S. No. 5246.
